While keeping this in mind, the ownership of Tata Coin's smart contract, which is deployed to the Binance Smart Chain, has been renounced so that no one can change its functions in the future. WHY AND HOW DOES THE COMMUNITY OWN THE TATA COIN?

Further clarification regarding the Tata Coin team

There are many risks involved in other cryptocurrencies. We understand this and have the skills, experience, and leadership to overcome them.

The basic and important role of any cryptocurrency is its supply; the one who has the most supply of the Cryptocurrency is the real owner of the Cryptocurrency.

It is not necessary that the person or group who has developed or launched a cryptocurrency is the owner of it, but the real owners of any cryptocurrency are only the people who have a huge amount of supply. Because the one, who has the most supply, actually owns the assets of all the investors in the liquidity pool, he can seize people's assets by selling his supply if he wants.

Whenever an investor buys any cryptocurrency, his asset goes into the liquidity pool and in return, the buyer is given cryptocurrency coins and according to the principle of demand and supply that is why the value of coins also increases. On the other hand, if someone sells cryptocurrency, the coins sold go back to the liquidity pool and in return, the seller gets the assets back from the liquidity pool. That is, all the assets of the buyers of cryptocurrency go to the liquidity pool and the one who has the most supply is the owner of the assets in this liquidity pool and he is the one who controls the price of the cryptocurrency. This is a very important issue and only Tata Coin presented a solution to this problem.

Tata Coin has a supply of 9 million which cannot be increased and 100% of its supply is owned by no one but the community.

That is, only investors own the assets in the liquidity pool. Apart from investors, no one has a supply of Tata Coins.

That is why Tata Coin has no owner other than the investors. Tata Coin is a 100% community-driven Digital Currency because the entire supply of Tata Coin is in the hands of the Community, the Developers of Tata Coin have 0% supply of Tata Coin. Tata Coin does not have a developer's wallet that has supplies.

A SCARCE DIGITAL CURRENCY WITH A KNOWN, FIXED SUPPLY

The TATA Coin protocol ensures there will never be more than 9 million coins in existence. Governments constantly print money out of thin air, endlessly inflating the supply and devaluing everyone's savings. TATA Coin has a fixed supply and therefore represents sound money.

TRANSPARENT

All transactions are recorded on a global public ledger called the blockchain. The ledger is updated at regular intervals in blocks that are connected to form a chain. This allows anyone to easily see the full history of ownership and helps to eliminate the potential for fraud.

Identities are not tied to transactions. This helps to ensure that TATA Coin remains free to be used by anyone, without censorship.

TATA COIN ECOSYSTEM

What is TATA Coin used for?

Thanks to its low transaction fees and fast confirmation times, there will be a growing number of use cases for TATA Coin. These range from games that integrate TATA Coin payments, to social networks and publishing platforms that allow you to tip using TATA Coin.

There are several use cases of TATA Coin, but we will focus on some of the financial-related cases.

INTERNATIONAL PAYMENTS

TATA Coin can make international payments faster and cheaper. Since TATA Coin is not issued by a central authority and is effectively borderless, you can bypass the several intermediaries needed to process the transaction. Transactions can happen on the same day safely and securely without any verifications by any central authorities, Banks, etc.

ALTERNATIVE BANKING AND WORLDWIDE PAYMENTS

A decentralized financial system democratizes finance and gives the unbanked access to services that a traditional financial institution would deny based on existing standards. In emerging markets, those outside the banking ecosystem are using mobile phones to access cryptocurrencies, as it's a viable alternative to a bank account and a way to protect their money from hyperinflation.

INVESTMENTS

TATA Coin has a limited and finite supply of coins, giving it the ability to keep inflation low. This stipulation encourages some retail and institutional investors to view TATA Coin as a store of value and invest in it as a form of "digital gold."

LONG-TERM STORE OF VALUE

The total supply of TATA Coin will never exceed 9 million coins. This is written into the code that defines the TATA Coin protocol.









As a decentralized network, TATA Coin users ultimately decide how the protocol evolves – and since it is not in the interests of participants to dilute their holdings by changing the protocol, the 9-million-coin limit will almost certainly remain in place forever.

TATA Coin's 'set-in-stone' supply schedule makes it unique among hard assets. By comparison, the supply of gold, although limited, is nevertheless subject to the forces of supply and demand. As the price of gold rises, more gold miners are incentivized to search for gold. The leads to an increase in the supply of gold, which places downward pressure on the price.

HIGHLY EFFECTIVE MEDIUM OF EXCHANGE

TATA Coin enables peer-to-peer payments between individuals – just like cash, but in the digital realm. Critically, fees for sending TATA Coin typically amount to less than a penny per transaction, and settlement occurs near-instantly, regardless of the physical location of participants. This makes TATA Coin useful for not only remittances and cross-border trade, but also for daily transactions like buying groceries. Since the fees and transaction times are so low, TATA Coin is also effective for micro-transaction use cases like tipping content creators and rewarding app users.

TATA (DAPP & DEX) DECENTRALIZED EXCHANGE

In the future, we will build a decentralized swap (DAPP) and exchange (DEX), where TATA Coin will be used as one of the key base assets as well as gas to be spent.
